National deviations:	<ul style="list-style-type: none"> <li>- As set in the applicable standard for each product</li> <li>- Equipment, machines and apparatuses shall bear a label affixed on the body or package indicating the country of origin in Arabic, English or French (Decree 770: 2005)</li> <li>- If ready-made clothes, linens, carpets and rugs (except for socks and imports for medical purposes and industrial security) the following shall be applied (Decree 770: 2005 with amendment decree number 32: 2006):</li> </ul>

	<p>A woven data card in Arabic shall be affixed on each batch in the process of manufacture with the following:</p> <ul style="list-style-type: none"> <li>a) Type of material used (composition)</li> <li>b) Country of origin</li> <li>c) Name of the importer</li> </ul> <ul style="list-style-type: none"> <li>- Brand/manufacturer name or trade mark and country of origin shall be scorched on porcelain tableware under the glaze layer (Decree 770: 2005 Annex3)</li> <li>- Manufacturer name, country of Origin, fabric type with its composition (e.g. Cotton 100%) and name of the importer shall be printed at equal intervals on the dyed, printed or finished fabrics (excluding synthetic mink, thick and blackout curtains and products under Chapter 58 of the HS tariff code (Decree 770: 2005 Annex3).</li> </ul>
Labelling requirements:	Labels, markings and instructions shall be legible, well stuck, not easy to remove, and at least in Arabic language unless otherwise specified in the applicable standard or national deviations
Other specific requirements (*):	<ul style="list-style-type: none"> <li>- The following refrigerants are banned to be used in apparatuses and equipment: R-11, R-12, R-13, R-22, R-113, R-114 and R-115 (Decree 770: 2005 Annex 3)</li> <li>- Energy Efficiency labels shall accompany Air Conditioners, Washing Machines, Refrigerators and Freezers, electric fan, electric storage water-heaters, dishwashers and televisions according to the applicable standards for energy efficiency.</li> </ul>
